

## Carrier Disbursement Charges v1.0

Following implementation of the UK-EU trade deal on 01.01.21, carriers are charging additional disbursement fees on shipments to the EU sent with DAP terms. This means that receivers are now required to pay disbursement fees on top of the necessary duty and taxes for each delivery. Carriers are applying these extra charges to cover the prepayment of duty and taxes on behalf of their customers. The amount charged varies from carrier to carrier and according to destination. See below for a list of disbursement fees per country as charged by DHL, DPD and UPS. Please note that all carriers charge VAT on disbursement fees.
